

ORDINANCE NO 199#

AN ORDINANCE OF THE TOWNSHIP OF AMITY, BERKS COUNTY, PENNSYLVANIA, AMENDING AND RESTATING IN ITS ENTIRETY SECTION 203(a), ENTITLED "MAXIMUM SPEED LIMITS ESTABLISHED", OF PART 2, ENTITLED "TRAFFIC REGULATIONS", OF CHAPTER XIX, ENTITLED "MOTOR VEHICLES AND TRAFFIC" OF THE TOWNSHIP OF AMITY CODE OF ORDINANCES BY ADDING THERETO THE PROVISIONS TO ESTABLISH THE MAXIMUM SPEED LIMIT ON THE ENTIRE LENGTH OF WORMAN ROAD TO BE SET AT 25 MPH

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Amity, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. Section 203(a), entitled "Maximum Speed Limits Established", of Part 2, entitled "Traffic Regulations", of Chapter XIX, entitled "Motor Vehicles and Traffic" of the Township of Amity Code of Ordinances is hereby amended in its entirety so as to read as follows:

"Section 203. Maximum Speed Limits Established.

(a) The following speed limits are hereby established pursuant to the appropriate engineering and traffic count studies as required by the Pennsylvania Motor Vehicle Code (Title 67. Transportation, Chapter 201. Engineering and Traffic Studies, Subchapter C):

SECTION 2. Any and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any sentence, clause, section or part of this Ordinance is, for any reason, found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impact any other remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Township of Amity that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof had not been included herein.

SECTION 4. This Ordinance shall be come effective five (5) days following the date of adoption.

SECTION 5. The Code of Ordinances, as amended, of the Township of Amity, Berks County, Pennsylvania, shall be and remain unchanged and in full effect except as amended, supplemented and/or modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances, as amended, of the Township of Amity, Berks County, Pennsylvania, upon adoption.
