

**RESOLUTION NO. 08-02**

**A RESOLUTION AMENDING THE FEE SCHEDULE  
OF THE TOWNSHIP OF AMITY, PENNSYLVANIA.**

**BE IT IS HEREBY RESOLVED** by the Board of Supervisors of Amity Township, Berks County, Pennsylvania, that, pursuant to the grant of powers set forth in the Second Class Township code and/or municipal codes passed by the General Assembly of the Commonwealth of Pennsylvania, the current Schedule of Fees for the Township of Amity, Berks County, Pennsylvania, is as follows:

Certificate of Insurance naming Amity Township as additional insured. Building permits will not be released until appropriate contractor has provided a certificate and paid for registration. Registration will be valid for 1 year from date of issuance, Name and contact information will be listed on the Amity Township on website

**ORDINARY REPAIRS**

Ordinary repairs do not require any permit or fee. Ordinary repairs shall include repairs of installation of down spout and rain gutters, masonry pointing, interior floor coverings, fencing concrete, wood or stone walkways on grade not for use by the public nor attached to or part of any structure and two (2) feet or less in height above grade; replacement or repair of existing roof covering; repairs and/or replacement of metal or vinyl siding; installation of interior

decorative wall covering on existing walls such as wall papering, wood veneer panels and wood or plastic trim moldings.

Ordinary repairs **SHALL NOT** include cutting away of any wall, partition or portion thereof, the removal or cutting of any structural beam or bearing support, or the removal or change of any required means of egress, or rearrangement of parts of a structure affecting the exit requirements; nor shall ordinary repairs include addition to structures.

### **PERMIT FEES**

#### **I. ZONING PERMIT FEES**

- A. All accessory structures 500 square feet and less, with the exception of private in-ground swimming pools, are required to have only a zoning permit. Structures over 200 square feet but less than 500 square feet must have anchorage. The Zoning permit fee for these structures shall be \$50.00.
- B. A zoning permit is required in conjunction with every change in the use of land or structure, or material improvement outside the existing building footprints. The zoning permit fee is \$50.00.

### **BUILDING PERMIT FEES ONE and TWO FAMILY DWELLING CONSTRUCTION**

- A. New home construction, \$0.30 per square foot of building or structure space, including porches, patios, basements, garages, and living areas. Crawl spaces and dead area spaces such as attics (with or without a finished floor) providing structural headroom of seven feet, six inches less than 50% are excluded. There is a minimum permit fee of \$400.00.
- B. For residential additions including attached garages, the minimum building permit fee is \$250.00. Structures exceeding 800 sq. ft., including porches, attics (providing structural headroom of seven feet, six inches over more than 50%), basements, garages, and living areas, will be calculated at \$0.30 per sq. ft.
- C. For detached garages over 500 square feet and accessory structures over 500 square feet \$0.30 per square foot of building or structure area (total area, each level) is charged. There is a minimum permit fee of \$150.00.
- D. For private in-ground swimming pools, \$0.30 per square foot of structure area, including surrounding patio/deck, is charged. There is a minimum permit fee of \$150.00.

E. For above ground pools, wood decks and where none of the above categories apply, \$0.30 per square foot of building or structure area (areas with at least minimum height ceilings). There is a minimum building permit fee of \$100.00.

F. The building permit renewal fee is \$30.00.

G. Additional or re-inspections will be billed to the applicant on a per inspection basis. The fee for each inspection will be \$50.00

H. Mandated Municipal Code official training account fee for any construction or building permit package issued under the UCC is \$4.00 per project.

1. **NON-RESIDENTIAL and RESIDENTIAL** other than ONE and TWO FAMILY USES (Plumbing Permit Fees and Mechanical Permit Fees are included and will be listed on the building permit. Electrical Permit Fees are additional.)

A. New Construction (Buildings and Additions)

First 1,000-2,000 sq. ft. \$0.50 per sq. ft.

Next 2,000 – 10,000 sq. ft. \$0.40 per sq. ft.

Remaining Area over 10,000 sq. ft. \$0.30 per sq. ft.

B. Alterations, Renovations and Tenant Fit Outs

First 1,000- 10,000 sq. ft. \$0.35 per sq. ft

Remaining Area over 10,000 sq. ft. \$0.25 per sq. ft.

C. Miscellaneous construction (discretion of Building Code Official only)

a. 0.7% of the cost of construction

**Building Inspection Penalties – The following penalties are in effect for all inspections required of the Building Inspector:**

Normal fee x 2 – Permits obtained as a result of a stop work order being issued and/or construction, installation, etc. that has been completed.

Exact Cost incurred by Township – Special test and/or agencies required to determine compliance with concealed construction and/or work completed prior to obtaining a permit.

Applicant may also be required to produce own approved proof of compliance (i.e. compaction test).

Inspections \$50.00 – per visit in excess of two (2) on the same matter (i.e. framing inspection).

Fee must be paid before further inspections take place.

**SUBDIVISION AND LAND DEVELOPMENT**

**PLAN REVIEW FEES**

The applicant shall reimburse the Township for all reasonable administrative and professional expenses, including but not limited to engineering and/or consultant fees. Prior to the filing of a preliminary plan, and prior to the filing of a final plan, the applicant shall pay to the Township the appropriate non-refundable filing fee and an escrow deposit to defray the professional expenses incurred by the Township in accordance with the fee schedule adopted by the Board of Supervisors. Thereafter, as the escrow deposit for expenses incurred is expended, the applicant shall make further deposits upon notice from the Township until approval of the Plan. Upon approval of the Final Plan, the Township shall refund any uncommitted portion of the deposit remaining after expenses incurred by the Township have been paid in full by the applicant. To the engineering and legal fees required to be paid to the Township by this part, there shall be added 15% as reimbursement to the Township of the costs incurred by the Township for the collection of such fees and the disbursement of the same to the Township Engineer and Solicitor. All current fees are covered under section 308 of the Amity Township Subdivision and Land Development Ordinance.

The appointed Sewage Enforcement Officer shall be compensated at a rate of \$51.25 or \$57.75 per hour plus out of pocket expenses, including mileage at the prevailing PA DEP rate, and a digging and presoak fee of \$56.00 for each perc test performed.

\$1,000.00 – in addition, applicant shall deposit \$1,000.00 with Amity Township to be held in escrow.

\$750.00 – Challenge to any provision to the Zoning Ordinance and/or ordinance amendment. In addition, applicant shall deposit \$2,000.00 with Amity Township to be held in escrow.

**Conditional Use Hearing**

Hearing before the Board of Supervisors, for land specifically authorized as conditional under the zoning ordinance.


