


RESOLUTION 10-

A RESOLUTION OF THE TOWNSHIP OF AMITY, BERKS COUNTY, PENNSYLVANIA RELATING TO ENFORCEMENT OF THE VEHICLE CODE ON THE PROPERTY OWNED BY THE DANIEL BOONE SCHOOL DISTRICT

BE IT RESOLVED by the Board of Supervisors of Amity township that in accordance with 75 PA. C.S. Section 6113 that the Amity Township Police Department began enforcing all Pennsylvania Vehicle Code violations contained at Title 75 of the Pennsylvania Vehicle Code on the Amity Primary Center, Amity Intermediate Center, Daniel Boone Middle School and Monocacy Elementary Center. This is in accordance with the request of the Daniel Boone Area School District dated October 28, 2010 and shall remain in effect until such time as the Daniel Boone Area School shall rescind its authorization to enforce the Vehicle Code on its property. A copy of the letter of October 28, 2010 is attached to this Resolution.



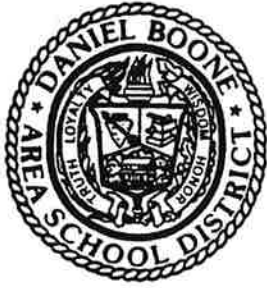
